

**AMIAS Background Check Form - BCI**

**Instructions**

1. Fill in the blanks below. Having a driver's license is not required to be AMIAS certified. However, all Utah resident drivers are required to have a UT driver's license (rather than one from another state).
2. Sign and date the "volunteer signature" line of the waiver below.
3. Obtain one fingerprint card. Applicants may have their fingerprints taken at Utah BCI (3888 W 5400 S, SLC) or at most local law enforcement offices for a nominal fee. Fingerprint cards must contain all descriptive information.

Check consists of: Western Identification Network\*\*, Utah Criminal History, Statewide Warrant and Protective Order, and Federal Want and Warrant files. By law, applicants may not see these results. (Personal copies may be obtained from the Utah Bureau of Criminal Identification, however.) Criminal histories and the top half of this form will be shredded or incinerated once reviewed by the Area Alateen Process Person. Only the waiver portion of this form will be kept on file (required by law).
